

Shareholders Communication Policy

1. Introduction

The Company recognises the value of providing current and relevant information to its shareholders.

The Managing Director/Chief Executive Officer (or while the Company does not have a Managing Director/Chief Executive Officer, the Chairman) and Company Secretary have the primary responsibility for communicating with shareholders.

Information is communicated to shareholders through:

- (a) continuous disclosure to relevant stock markets of all material information;
- (b) periodic disclosure through the annual report (or concise annual report), half year financial report and quarterly reporting of corporate activities;
- (c) notices of meetings and explanatory material;
- (d) the annual general meeting;
- (e) periodic newsletters or letters from the Chairman or Managing Director/Chief Executive Officer; and
- (f) the Company's website at www.madergroup.com.au.

The Company is committed to the promotion of investor confidence by ensuring that trading in the Company's securities takes place in an efficient, competitive and informed market.

2. Electronic communication and website

The Company believes that communicating with shareholders by electronic means, particularly through its website, is an efficient way of distributing information in a timely and convenient manner.

The Company's website includes the following pages, which contain relevant information for shareholders

- (a) section on the Company's corporate governance policies and practices;
- (b) reports section, which contains copies of annual, half yearly and quarterly reports;

- news section, containing sections on newsletters, ASX announcements, media briefings and clippings and power point presentations;
- (d) press releases; and
- (e) research section, which contains broker research reports published on the Company.

The Company's website will be updated with material released to the ASX as soon as practicable after confirmation of release by the ASX.

All website information will be regularly reviewed and updated to ensure that information is current, or appropriately dated and archived.

The Company places the full text of notices of meeting and explanatory material on the website.

3. Written communication and annual report

Shareholders have been given the opportunity to elect to receive a printed copy of the annual report from the Company. In addition, the Company publishes its annual report on the Company's website and notifies all shareholders of the web address where they can access the annual report.

4. Annual general meeting

The Company recognises the rights of shareholders and encourages the effective exercise of those rights through the following means

- notices of meetings are distributed to shareholders in accordance with the provisions of the Corporations Act;
- (b) notices of meeting and other meeting material are drafted in concise and clear language;
- shareholders are encouraged to use their attendance at meetings to ask questions on any relevant matter, with time being specifically set aside for shareholder questions;
- if shareholders are unable to attend a meeting, notices of meetings encourage participation in voting on proposed resolutions by lodgement of proxies;
- (e) all substantive resolutions at a meeting of shareholders will be decided by poll rather than show of hands;
- (f) it is general practice for a presentation on the Company's activities to be made to shareholders at each annual general meeting; and

(g) it is both the Company's policy and the policy of the Company's auditor for the lead engagement partner to be present at the annual general meeting and to answer any questions regarding the conduct of the audit and the preparation and content of the auditors' report.

5. Other communication

The Company encourages two way communication with its shareholders to allow investors and other financial market participants to gain a greater understanding of the Company's business, governance, financial performance and prospects. It encourages investors and other financial market participants to express their views to the entity on matters of concern or interest to them.

Where significant comments or concerns are raised by investors, their representatives, these will be conveyed to the relevant senior executives and the Board.

This policy is reviewed annually.
